**Description/Background:**

Resolution 2010-05 authorizes the Harbor Director to conduct a public auction of the Vessel *Iroquis*, a 25 foot fiberglass sailboat, to the highest and best bidder. The resolution further authorizes the Harbor Director to bid all or part of the accrued Port charges at the sale and the Port of Olympia may become the purchaser at the sale. With Commission approval the auction will be set at a future date to be held at Swantown Marina. Estimate value of vessel: \$3,500.00 Total owed for past due charges at Swantown Marina as of February 8, 2010: \$1,427.81. Additional charges will continue to accrue up until the auction date.

**A resolution of the Port of Olympia Commission authorizing the sale of an abandoned vessel.**

WHEREAS, the vessel *Iroquois* WN 5514 JD, a 25 foot fiberglass sailboat located at Swantown Marina was seized for non-payment of moorage fees and related charges; and

WHEREAS, notification of the seizure was provided to the owner of the vessel *Iroquois* WN 5514 JD, a 25 foot fiberglass sailboat on or about November 18, 2009 as required by RCWs 53.08.320(1); and

WHEREAS, the owner of the vessel *Iroquois* WN 5514 JD, a 25 foot fiberglass sailboat has failed to pay the port charges due within ninety days of the notice; and

WHEREAS, the vessel *Iroquois* WN 5514 JD, a 25 foot fiberglass sailboat is therefore conclusively presumed to be abandoned under RCW 53.08.320(4); and

WHEREAS, RCW 53.08.320(5) allows the Port of Olympia Commission to authorize the public sale of the vessel *Iroquois* WN 5514 JD, a 25 foot fiberglass sailboat by authorized personnel to the highest and best bidder for cash.

NOW THEREFORE,

IT IS RESOLVED that Bruce Marshall, Harbor Director for the Port of Olympia is hereby authorized to conduct a public auction of the vessel *Iroquois* WN 5514 JD, a 25 foot fiberglass sailboat to the highest and best bidder;

IT IS FURTHER RESOLVED that Bruce Marshall, Harbor Director is authorized to bid all or part of the accrued port charges at the sale and the Port of Olympia may become a purchaser at the sale.
